Pre-event Class Rules Compliance Inspection and Timetable

Class Rules compliance inspection for all Teams competing in the International NACRA17, 49er, 49erFX Class 2018 Junior World Championship shall commence:

Sunday 26th of August 08:30 to 18:30

Monday 27th of August 08:30 to 13:30

Note: no Team shall be considered for pre-event measurement the full Equipment Declaration Form has been completed where required by the Team.

All Teams are reminded that Mainsails shall be presented with the correct Country Code and Sail Number in place.

Hulls shall be dry and drained of any internal water. Failure to comply will see offending teams hull quarantined until such time its dryness satisfies the inspection team. Teams are reminded that tillers are also to be water free.

Sail numbers shall be that of the World Sailing (ISAF) hull plaque, 2018 Class Rule or 2017 World Championship Top 25 placing. Incorrect identification (Sail Number) will not be event approved.

All competitors are reminded that in accordance with RRS 78.1 you are responsible for ensuring that your equipment is maintained in accordance with the current Class Rules. In particular equipment requiring a Certified Equipment sticker as in accordance with the International NACRA17, 49er, 49erFX Class Rules shall do so. Should a sticker have been lost and or damaged please mark form accordingly.

Remember - Blank forms will not be accepted meaning that a team will be relegated to the end of the timetable.

Note: please ensure your boat complies with the inforce Class Rules.

Pre-event inspection shall be by Country and the Team being inspected and or coach/manager shall only be permitted in the measurement area throughout the pre-event period.
